Sex offender registration question:

if a youth is being released and ordered to register within 3 days who is responsible is responsible to notify the local sheriff's department of transfers and releases; parole or probation?

Response from the board: It is the youth's responsibility to notify and keep the sheriff's department away of any changes in location or status after release.

However, if a youth is released and held in detention pass the 3 days window then it is the county's responsibility. They then need to register again in their new county.
